3. Supervising the Board of Management by the Board of Directors:

❖ Supervision methods:

- Based on the Company's Charter and Corporate Governance Regulations, the Board of Directors assigns specific tasks to each member to monitor each area of the Company's operations, in the fields of financial management, production management, business, and investment.

- BOD members regularly exchange information and consult on important issues in the operation of the Company via email and telephone in addition to regular meetings and extraordinary meetings. Promoting the supervision of the BOM and subordinate departments/units to ensure the Company's business operations are in accordance with the Resolutions of the GMS, the Company's production and business activities are effective and comply with regulations.

❖ Implementation of the 2024 Production and Business Plan:

In 2024, the economy faced many difficulties, and decreased purchasing power led to a decline in consumer demand for goods. Currently, many individual units producing bird's nest beverages are widespread and increasingly complex in the market. The problem of counterfeit and imitation goods of Khanh Hoa Salanganes Nest, Sanest, and Sanvinest brands taking place publicly has caused confusion for consumers, significantly affecting the prestige, brand, and production and business results of the Company. With the close direction and guidance of the BOD and the BOM, the efforts of all employees, and the support of customers and market regions, SKH has strived to achieve the production and business plan targets and the General Meeting of Shareholders' Resolution No. 02/2024-DHDCD for 2024.

- Regarding production and technical technology:

+ Promoting the strength of being a unit directly exploiting the natural Khanh Hoa Island Bird's Nest raw material source, affirming the brand's position, trust and expectations of customers, the Company always focuses on improving quality, diversifying products and providing the market with nutritious and high-class bird's nest product lines to meet customer needs and tastes.

+ Implementing the production and business development strategy with the goal of continuously improving product quality and accompanying community health, the Company officially introduced Sanest products with increased bird's nest content from 21% or more in bottled product lines and 7.5% in canned product lines. This is the result of scientific research, practical experience, and the dedication of the Company's employees with the desire to bring customers superior quality products and improve community health.

+ Invested in equipment and machinery systems to enhance product quality, shifting from traditional packaging to innovative 3D Jade Eye printing technology, receiving positive feedback from consumers. Implemented quality improvements in packaging using modern, convenient printing technology with anti-counterfeiting measures.

+ Sanest Khanh Hoa has focused on applying science and technology to production and business, maintaining and improving the effectiveness of the management system according to ISO 9001:2015, ISO 14001:2015, ISO 22000:2018, HACCP, Halal, the US Food Safety Modernization Act (FSMA), and Brand Reputation Compliance Global Standards (BRCGS) to optimize and elevate product quality.

+ Collaborated with Khanh Hoa Salanganes Nest Soft Drink Joint Stock Company to research low-sugar product lines, aligning with current market trends.

+ Applied digital transformation, developing specialized software for comprehensive integration from production to business, creating a unified and consistent data system from input to output, tightly controlling production processes, goods distribution, traditional and modern business, domestic and international operations, and a traceability system, promoting system growth. Applied AI technology in statistics, control, and decision support.

- Regarding business and brand development:

+ Faced with fierce market competition, especially the widespread and overt presence of counterfeit and imitation goods, Sanest Khanh Hoa has implemented various measures to enhance the effectiveness of sales promotion programs and sales policies, as well as to protect the Company's brand.

+ The Company continuously innovates and remains flexible in applying appropriate promotional programs and implementing adaptable sales policies to attract and retain customers.

+ The Company has expanded collaboration with partners and increased the presence of Promotion Girl (PG) at points of sale, enhancing customer care, support, and consultation. Promotional programs are diverse in format: offering preferential pricing for consumers, providing cash rewards or summer travel tours to incentivize and motivate sales points.

+ In 2024, the Company restructured its domestic market distribution system, promoting online sales channels and e-commerce platforms.

+ Established quarterly and annual bonus policies, including birthday bonuses for distributors and agents. Invested in sales support, building a professional distribution system across various channels to adapt to the current situation, continuing to develop traditional channels in the provinces, expanding modern channels with product presence on shelves and counters, and exploring additional sales channels in canteens, schools, hospitals, and industrial zones.

+ Increased promotion through mass media, strengthened marketing efforts, developed sales programs tailored to specific customer segments, and enhanced collaboration with associations, organizing programs such as bringing Vietnamese goods to rural and mountainous areas, and Vietnamese people give priority to using Vietnamese goods to facilitate access and usage of the Company's products by a wider range of customers.

+ The implementation of Distribution Management System (DMS) software has enabled the Company to control data within the supply chain. The automation features of the DMS application on mobile devices have supported continuous market monitoring, tracking sales staff's sales activities, and rapid sharing of business information through data on sales, inventory, coverage, and competitor information. This has enabled the Company to quickly update business situations and handle market information promptly.

+ In export activities, Sanest Khanh Hoa expanded market development in countries where Sanest products are already present, such as the US, Australia, Canada, Japan, Taiwan, UK, Myanmar, Hong Kong, Philippines, Thailand, New Zealand, and South Korea... Developing sales programs and marketing and supporting product promotion. Carrying out registration of SKHPearlNest products for official export to markets like the USA, Canada, Australia, the Philippines, and Hong Kong... Active participation in trade fairs and exhibitions to promote the brand contributed to introducing Sanest Khanh Hoa products to the world.

+ Marketing activities on digital platforms like Facebook, Google, and e-commerce platforms have been strengthened and innovated according to each consumer phase, achieving certain effectiveness. The Sanest Khanh Hoa brand and products have been remained a top choice in the premium nutritional beverage segment. In 2024, the company's online sales channels recorded 42.45 million visits, with revenue reaching 171% of the annual plan.

+ Continued investment and development of the Svmart brand, SKHlife sports drinks, and SKHPearlNest premium bird's nest products.

+ Investment in the Sanest Khanh Hoa volleyball team with famous athletes aimed to achieve high performance in domestic and international tournaments, linking sports with product and brand promotion through the renowned team to reach customers.

- Regarding finances:

+ The financial situation was closely monitored, providing complete and timely reports as required by the Law on Accounting and the Law on Securities.

+ Continuous updates and application of circulars, decrees, and legal documents of the State related to finance and accounting.

+ Proactive exploration of capital sources and mobilization of loans with the lowest interest rates to ensure timely service for production, business activities, and investment projects.

+ Inspection and supervision of financial receipts and expenditures, tax obligations, debt payments; inspection of asset management and the sources of asset formation; detection and prevention of violations of financial and accounting laws, limiting risks in tax management.

+ Analysis of accounting information and data, consultation, and proposal of solutions to serve management and administration requirements.

- + Provision of accounting information and data as prescribed by law.
- + Timely salary and bonus payments, periodic and unscheduled inventory checks, fulfillment of state budget obligations and social insurance.

- Investment projects: Continuation of the joint venture program to develop the bird's nest house and cave system to ensure input materials for the company's production and business activities.

- Regarding employee welfare and social activities:

+ Employee welfare: The Company's leadership consistently ensured employee livelihoods and income, continuously improving salary, bonus, and benefit policies. The company's union has planned to implement the "Union Member Welfare" program, opening a non-profit stall on the company premises to create a joyful atmosphere for the Lunar New Year.

+ Alongside economic development, the company always ensured the harmony of interests with customers and shareholders; collaborating with society to implement social security programs, assisting difficult circumstances and areas, accompanying children and poor studious students. This included supporting gifts for disadvantaged children in Cam Lam and Cam Ranh during the Mid-Autumn Festival; donating to compatriots affected by storm number 3; donating three charity houses in Cam Ranh City and Van Ninh District, supporting five houses in response to the movement to eradicate temporary housing launched by the Vietnam Fatherland Front Committee of Khanh Hoa Province, bringing the total number of charity houses donated by the company to 21.

❖ **Monitoring Results:**

In 2024, the Company's production and business activities faced numerous difficulties due to a slow consumer market, and the continued prevalence of counterfeit and imitation goods, severely impacting the Company's business operations. The Board of Management and all employees of the Company have promoted collective strength, unity, and consistent will and action, along with innovative thinking and enhanced production and business efficiency. Coupled with customer support, these efforts contributed to the accomplishment of the 2024 plan with the following results:

- + Revenue: 1,177.3 billion VND, achieving 100.6% of the annual plan.
- + Pre-tax profit: 71.3 billion VND, achieving 101.9% of the annual plan.
- + Budget contribution: 68.8 billion VND.
- The business activities of the two subsidiaries have preserved their equity and expanded production and business operations to enhance efficiency, with the following results:
 - + Sanest Khanh Hoa One Member Limited Liability Company: Revenue: 276.761 billion VND; pre-tax profit: 5.966 billion VND.
 - + Salanganes Nest Special Processing One Member Limited Liability Company: Revenue: 160.049 billion VND; pre-tax profit: 7.869 billion VND.
 - + The Board of Directors agreed on the merger of the two subsidiaries to centralize management, expand scale, and increase financial strength to maintain market position and protect interests against competitors.
 - + Facing increasingly fierce competition, to enhance operational capacity, apply science and technology, innovate, optimize costs, and increase efficiency in production and

business, and ensure effective human resource utilization, the Board of Directors has implemented organizational restructuring and workforce reduction in an objective and fair manner, ensuring full benefits for employees after reduction in accordance with legal regulations.

+ To affirm product quality, the Company consistently focuses on meeting requirements in production and business activities to achieve prestigious awards from industry organizations, national and international levels. Specifically: Khanh Hoa Salanganes Nest, Sanest Khanh Hoa, and Sanvinest Khanh Hoa brands continued to be recognized as National Brands in 2024; Global Performance Excellence Award (GPEA) with the highest category “World Class”; Products achieved Vietnam Value for the period 2024-2026; National Quality Gold Award 2022; Vietnam's No. 1 Brand in 2024; Top 10 Reputable Beverage Companies in 2024; Top 1 Leading Brand in Vietnam and Top 50 Trusted Products - Services in Vietnam 2024.

+ Disclose complete, timely, and transparent information to investors and shareholders. All information as regulated has been sent to shareholders and disclosed on mass media through the Hanoi Stock Exchange's website as well as the Company's website. On November 8, 2024, the Company was honored to receive the award “Large-scale Public Company on UPCOM for well performance in Information Disclosure and Transparency in 2023-2024”, marking the third time the Company has been honored at the Annual Business Conference organized by the Hanoi Stock Exchange.

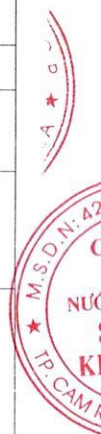
