**Disclosure content:** explanation of the 12% increase in profit after corporate income tax compared to the **same period** in 2023

Haiphong Electricity Water Machine Assembly Joint Stock Company would like to explain the fluctuation in profit after corporate income tax (CIT) in the 2024 financial statements as follows:

- Profit after tax in 2024 reached **VND 42,140,543,763** an increase of **VND 4,746,743,229** equivalent to **12%** compared to the same period in 2023.
- The main reasons for this increase are:
  1. Revenue from sales of goods and services in 2024 reached VND 937,408,787,887, an increase of VND 134,925,926,000 (equivalent to 16%) compared to 2023.
  2. Financial income in 2024 reached VND 1,656,053,081, an increase of VND 1,460,392,294 (equivalent to 846%) compared to 2023.

Thus, the growth in revenue from core business activities and financial income contributed to the increase in profit after tax in 2024.
