Khanh Hoa Sanest Soft Drink Joint Stock Company explains the after-tax profit in the Income Statement of the first quarter of 2025 increasing compared to the same period in 2024 as follows:

In the first quarter of 2025, the consumption demand during the Lunar New Year increased highly and the Company synchronously implemented sales policies, promotion programs, and support activities for distributors, which promoted consumption. At the same time, Khanh Hoa Salanganes Nest, Sanest, Sanvinest brand achieved "Vietnam Value" and the product won the Global Performance Excellence Award, the knowledge of Khanh Hoa Salanganes Nest exploitation and processing was included in the list of national intangible cultural heritage, the product increased the content of Salanganes Nest to the market in a timely manner, improved the beautiful and eye-catching packaging design, meeting customer requirements, along with communication programs on brand promotion, protection of intellectual property rights of the brand, and anti-counterfeiting, so revenue increased and efficiency increased highly compared to the same period last year.

As a result, the after-tax profit in the first quarter of 2025 of the Separate Financial Statement is 16,774 million VND (increasing by 30.66% compared to the same period last year), and the after-tax profit of the Consolidated Financial Statements is 17,152 million VND (increasing by 11.39% compared to the same period last year). These results show that sales policies have been effective clearly in the context of a market with many advantages at the beginning of the year.

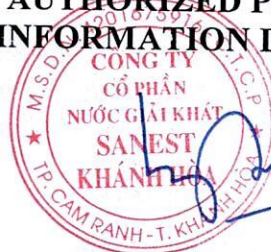
