In the first quarter of 2025, the Company's commercial activities continued to operate, resulting in a 1,128% increase in revenue compared to the same period in 2024. In addition, the Subsidiary made an accrual of interest expenses amounting to approximately VND 1.3 billion, leading to a 163% decrease in Profit after tax compared to the same period in 2024, during which the Company did not have sufficient evidence to accrue such interest expenses in advance.
