6. Disclosure Content:

- Consolidated financial statements and Separate financial statements and for the 4th quarter of fiscal year 2024-2025 (from January 1st, 2025, to March 31st, 2025) of HIPT Group Joint Stock Company (attached).

- Explanation of the differences between business performance results for the 4th quarter of the 2024-2025 fiscal year and the same period in the 2023-2024 fiscal year:

- Separate financial statements: Profit after tax for the 4th quarter of the 2024-2025 fiscal year recorded a profit of 8.32 billion VND, a decrease of 10.83 billion VND compared to the previous quarter. Profit after tax for the 3rd quarter of the 2024-2025 fiscal year recorded a profit of 19.1 billion VND due to the 3rd quarter of 2024-2025 recognizing revenue from major projects implemented in the 1st and 2nd quarter of the same fiscal year.
- Profit after tax for the 4th quarter of the 2024-2025 fiscal year increased by 11.69 billion VND compared to the same period in 2023-2024 (the 4th quarter of 2024-2025 recorded a profit of 8.32 billion VND, while the 4th quarter of the 2023-2024 recorded a loss of 3.37 billion VND). The reason is that the time for acceptance of completed projects takes place at different times in each fiscal year and because the time to implement projects has different lengths in each fiscal year.
- Consolidated financial statements: Consolidated profit after tax for the 4th quarter of the 2024-2025 fiscal year recorded a profit of 2.16 billion VND, an increase of 3.6 billion VND, compared to the Consolidated profit after tax for the 4th quarter of the 2023-2024 fiscal year, which recorded a loss of 1.44 billion VND. The reason is due to the great



influence of the project implementation time on the parent company's separate report as well as the acceptance time taking place in different quarters.
