4. Payment Date: Date July 30, 2025.

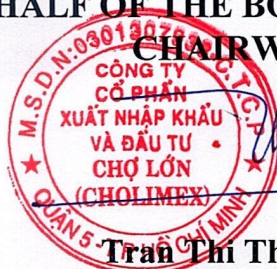
**Article 2.** Authorize the General Director of the Company to carry out relevant procedures for paying the 2024 dividends to shareholders in accordance with regulations.
