Pursuant to the information disclosure obligations of listed organizations as stipulated in Circular No. 96/2020/TT-BTC dated November 16, 2020 of the Ministry of Finance guiding information disclosure on the stock market, Dong Nai Roofsheets & Construction Material Joint Stock Company would like to explain to the relevant authorities as follows:

**1. Profit after corporate income tax in the income statement of the reporting period  
changed by 10% or more compared to the same period of the previous year:**

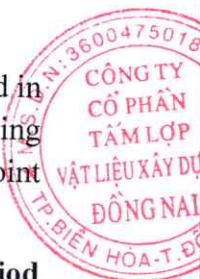
Net Profit after Income Tax on the Q2/2025 financial statements of the company recorded a loss of VND 14,470,697,261, reflecting a 14% reduction in loss compared to the same period in Q2/2024. This decrease in loss is due to the following reasons:

- The company, Dong Nai Roofsheets & Construction Material Joint Stock Company, signed a contract and received other income from exclusive production fees for the Nhon Trach plant, amounting to VND 14,000,000,000.
- Net revenue from sales and service provision in Q2/2025 increased by 195% compared to Q2/2024, primarily due to an increase in cement selling prices, which include material costs.

As a result, the business performance of Q2/2025 reduced the loss compared to the same quarter of the previous year.

**2. Profit after tax in the reporting period is a loss**

The net profit after income tax in the Q2/2025 financial statements of the company recorded a loss of VND 14,470,697,261 due to the following reasons:



Business operations in Q2/2025: The gross loss from the sale of goods and provision of services amounted to VND 4,723,764,048 due to the depreciation expense of the Nhon Trach plant totaling VND 7,463,325,487. However, the company was burdened by a high interest expense of 12.5% per year and overdue interest of 6.25% per year. The interest and overdue interest accrued in Q2/2025 amounted to VND 21.833.235.200. As a result, the net profit after tax recorded a loss.

This is the full explanation provided by Dong Nai Roofsheets & Construction Material Joint Stock Company regarding its financial statements for Q2/2025.

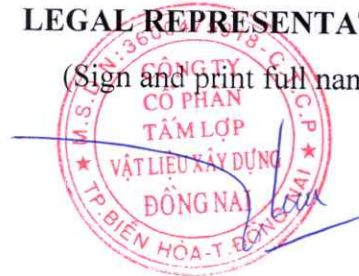
