In the first six months of 2025, The GMS of PC3-INVEST was held only once on April 16th, 2025 (Annual GMS), with no additional Extraordinary General Meetings or GMS conducted in the form of written comments.

In the first six months of 2025, the BOD of PC3-INVEST underwent personnel changes. Specifically, Mr. Nguyen Trong Vinh and Mr. Tran Dang Hien resigned from their positions as members of the Board of Directors for the 2023-2028 term. At the 2025 Annual General Meeting of Shareholders, Mr. Tran Cong Minh and Mr. Nguyen Tan Luc were elected as members of the BOD for the 5-year term (2025-2030).

3. Supervising the Board of Management by the BOD:

In the first six months of 2025, the BOD held 2 meetings and approved several matters presented by the General Director. All Board meetings were attended by members of the Supervisory Board passed several key resolutions for PC3-INVEST's operations, including: Provisional allocation of the total salary and remuneration fund for the 2025 plan; determination of the record date for exercising the right to attend and the schedule for the 2025 Annual General Meeting of Shareholders; approval of the finalization of the total salary and remuneration fund for 2024; approval of the 2025 electrical testing service contract for Đa Krông 1 Hydropower Plant; approval of the 2025 electrical testing service contract for Đắk Pône Hydropower Plant; agreement on the transfer and appointment of Ms. Huynh Thi Thuy Duong to the position of Deputy Head of the Finance Department; distribution of the 2024 management bonus fund; approval of the operating expense plan for 2025; selection of the auditing firm for the 2025 financial statements; and the 2024 cash dividend payment plan.

The BOD has supervised the management and operation of PC3-INVEST by the General director and has found that the Executive Board has fulfilled its assigned responsibilities in accordance with the Charter of PC3-INVEST, ensuring that the activities of PC3-INVEST comply with legal regulations, as follows:

- Regarding investment and construction activities

- i). Đắk Pône hydropower plant project (upgrading the A Lake's dam and constructing the B Lake hydropower plant)

- Construction of the B Lake hydropower plant

- Foundation Excavation: Foundation excavation has been completed, and the project has moved on to concrete construction of the plant. Drilling and installation of anchor bolts for slope stabilization of the penstock route have also been completed. Overall, the contractor's progress on the tasks remains slow.

- Hydromechanical Equipment: Installation of the pressure pipe section from anchor block No. 2 to anchor block No. 1 (80.24 meters) has been completed. Installation of the remaining 235-meter section is ongoing.

- Mechanical, Hydraulic, and Electrical Equipment: The contractor has delivered the equipment to the construction site warehouse and to Kon Tum City. The equipment is currently being stored and is ready for installation.

- Land Clearance and Compensation for the 22kV Transmission Line Route (the final land area of the project):

- + On June 24, 2025, the People's Council of Kon Tum Province issued a Resolution approving the list of projects for land-use conversion under the provincial planning for 2025. This includes the land area for the 22kV transmission line of the Đắk Pône Hydropower Plant Project. The project is currently awaiting a land-use conversion decision from the Kon Tum Provincial People's Committee.

+ The District People's Committee has approved the compensation plan. However, compensation payments to two households have not yet been accepted, despite multiple efforts by local authorities to persuade them. Meeting minutes have been prepared documenting their refusal, and the local authorities are continuing with procedures to issue the land recovery decision in accordance with regulations.

- Environmental Registration Documents: The consulting firm submitted the documents, and the People's Committee of Măng Đen Town officially received them on June 24, 2025.

ii). PC3-INVEST office headquarter project

- Construction work: completed wall construction and plastering, as well as stone tiling of the staircase. Installation of embedded systems for electricity, water supply, and fire protection has been finished. The contractor is continuing with interior and exterior tiling, installation of gypsum ceilings, wall and ceiling putty application, fabrication of glass doors and partitions, plastering of the front beams, and leveling of the basement area in preparation for equipment installation.

- Equipment Installation: The contractor has installed the embedded components of the air conditioning system on all floors (including the gas piping system, condensate drainage system, and power supply system), as well as the embedded components for the elevator system. Currently, the contractor is continuing with the installation of indoor and outdoor AC units in accordance with the construction progress

- Regarding Business Operations: during the first six months of 2025, the hydrological conditions at the Đắk Pône and Đa Krông 1 Hydropower Plants were unfavorable for power generation due to frequent rainfall; the electricity output was 50.66 million kWh, achieving 130.01% of the six-month plan; total revenue was 75.08 billion VND, reaching 124.43% of the six-month target; net profit after tax was 29.07 billion VND, reaching 105.2% of the plan set by the 2025 Annual General Meeting (27.63 billion VND).

PC3-INVEST has effectively implemented management activities such as continuing to strengthen the quality management system according to ISO 9001, executing corporate culture, and applying the 5S standard in the production process; cost-saving measures; and actively maintaining hydropower plants based on Risk-Based Management methodology. As a result, PC3-INVEST's operations have been strengthened, ensuring absolute safety in occupational health and safety and compliance with legal regulations in business operations and construction investment.

In the first six months of 2025, the Board of Directors (BOD) and the Board of Management (BOM) have actively directed and focused on management and operations with effective measures to successfully complete the set business plan objectives; the Company's production and business activities have been profitable; ensuring the preservation of shareholders' capital.

The activities of the BOD were carried out in accordance with the law, the operational charter of PC3-INVEST, and the regulations governing the BOD's operations. The BOD held regular meetings, engaged in collective discussions, and the meeting minutes were fully recorded. Resolutions and decisions were issued in accordance with the BOD's operating regulations.

The BOM of PC3-INVEST has performed its duties in managing the company with integrity, responsibility, and caution, in compliance with legal regulations, the company's charter, and the resolutions of the General Meeting of Shareholders and the BOD.
