6.2. Explanation:

Regarding the difference in post-tax profit on the Income Statement for Q3 2025 compared to Q3 2024:

- In the Company's Separate Financial Statements:
 - Post-tax profit for Q3 2025: VND 40,278,073,492
 - Post-tax profit for Q3 2024: VND 2,213,252,935
- In the Company's Consolidated Financial Statements:
 - Post-tax profit for Q3 2025: VND 71,540,106,599
 - Post-tax profit for Q3 2024: VND 21,908,783

Post-tax profit in the Separate Financial Statements for Q3 2025 increased by 1,720%, and post-tax profit in the Consolidated Financial Statements for Q3 2025 increased by 326,436% compared to Q3 2024.

Reason: In Q3 2025, the company recorded financial income from the transfer of shares in Tu Hiep Hong Ha Petroleum Joint Stock Company, resulting in a significant



increase in post-tax profit in both the Separate and Consolidated Financial Statements compared to Q3 2024.

Regarding the post-tax profit in Q3 2025 on the Separate and Consolidated Financial Statements:

- Post-tax profit in the Separate Financial Statements for Q3 2025: VND 40,278,073,492
- Post-tax profit in the Consolidated Financial Statements for Q3 2025: VND 71,540,106,599
