## DECISION

### **On enforcement of an administrative decision on tax administration by the measure of suspension of invoice usage**

*Pursuant to Article 34 of Decree No. 126/2020/ND-CP dated October 19, 2020 of the Government detailing a number of articles of the Law on Tax Administration;*

*Pursuant to Tax Arrears Notice No. 33275/TB-HCM-KDT dated December 09, 2025 issued by the Ho Chi Minh City Tax Department;*

### **HEREBY DECIDES:**

**Article 1.** To enforce, by the measure of suspension of invoice usage, against Petroleum Industrial and Civil Construction Joint Stock Company, Address: No. 35D, 30/4 Street, Tam Thang Ward, Ho Chi Minh City; Tax code: 3500832971, in order to enforce Tax Arrears Notice No. 33275/TB-HCM-KDT dated December 09, 2025 issued by the Ho Chi Minh City Tax Department.

Reason for enforcement: The taxpayer has tax arrears overdue for more than 90 days from the statutory payment deadline.

Amount subject to enforcement: VND 31,558,612,335;

*(In words: Thirty-one billion five hundred fifty-eight million six hundred twelve thousand three hundred and thirty-five Vietnamese dong).*

*Time of enforcement: At 15:48:54 on December 25, 2025 (applicable in cases where the taxpayer uses electronic invoices).*
