**NOTICE REGARDING THE OPENING OF THE FIRST INSTANCE TRIAL
OF THE CRIMINAL CASE AGAINST DEFENDANT DINH VAN TAO AND
ACCOMPLICES, PROSECUTED BY THE PEOPLE'S PROCURACY OF
TUYEN QUANG PROVINCE FOR THE CRIME OF "FRAUDULENT
APPROPRIATION OF PROPERTY" UNDER ARTICLE 174 OF THE
PENAL CODE**

On September 5, 2025, the People's Court of Tuyen Quang Province accepted the case file for the first instance criminal case No. 61/2025/TLST-HS against defendant Dinh Van Tao and accomplices, prosecuted by the People's Procuracy of Tuyen Quang Province for the crime of "Fraudulent appropriation of property" under point a, Clause 4, Article 174 of the Penal Code.

The content of the case shows: From 2015 to 2022, defendant Dinh Van Tao along with accomplices and related individuals at Top One Company committed acts of inflating charter capital to turn Top One Company into a public company, listing and offering 25,350,000 shares (Stock code TOP, with no guaranteed value) on the stock market, appropriating the assets of investors with a total amount of **64,735,740,000 VND** (Sixty-four billion, seven hundred thirty-five million, seven hundred forty thousand Vietnamese Dong). The Police Investigation Agency of Ha Giang Province (now the Police Investigation Agency of Tuyen Quang Province) identified those who initially purchased shares (F1) of Top One Company as victims, and current shareholders as persons with related rights and obligations to the case. Therefore, the investigation was entrusted to the Police Investigation Agencies of 37 provinces/cities to coordinate in taking statements from victims and persons with related rights and obligations to the case for investigation and clarification (*list attached*).

The People's Court of Tuyen Quang Province will open the first instance trial of the aforementioned case as follows:

- **Trial time:** 08:00 AM on January 26, 2026 (*the trial is expected to last for 05 days, starting from January 26, 2026, to January 30, 2026*).
- **Trial location:** Headquarters of the People's Court of Area 4 - Tuyen Quang; address: No. 331 Tran Phu Street, Ha Giang 2 Ward, Tuyen Quang City, Tuyen Quang Province.

In this case, there are many victims and persons with related rights and obligations; to ensure the legal rights and interests of those participating in the proceedings, the People's Court of Tuyen Quang Province notifies the victims and persons with related rights and obligations of the time and location to attend the trial and exercise their rights and obligations in accordance with the law.
