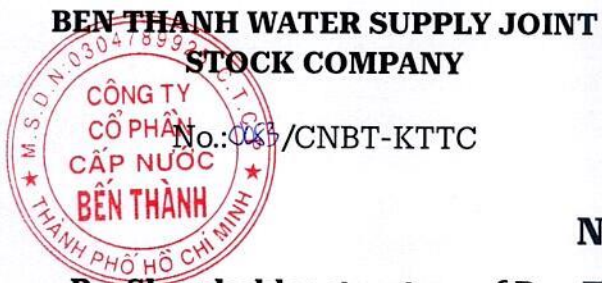

- Law No. 56/2024/QH15 dated November 29, 2024, amending and supplementing a number of articles of the Law on Securities, Law on Accounting, Law on Independent Audit, Law on State Budget, Law on Management and Use of Public Assets, Law on Tax Administration, Law on Personal Income Tax, Law on National Reserves, Law on Handling of Administrative Violations (hereinafter referred to as "Law No. 56/2024/QH15");
- Circular No. 96/2020/TT-BTC dated November 16, 2020, guiding information disclosure on the securities market;
- Circular No. 19/2025/TT-BTC dated May 05, 2025, prescribing the registration of public companies, cancellation of public company status, and reporting on audited contributed charter capital;
- Synthetic list of BTW securities owners as of December 31, 2025, provided by Vietnam Securities Depository and Clearing Corporation - Ho Chi Minh City Branch;

Ben Thanh Water Supply Joint Stock Company (Stock Code: BTW) respectfully announces a number of contents as follows:

1. According to the Synthetic list of securities owners provided by Vietnam Securities Depository and Clearing Corporation - Ho Chi Minh City Branch on the record date: December 31, 2025, the Company has **277 shareholders**, in which:

- **04 major shareholders** hold **92.84%** of the total voting shares, including:
 - + Saigon Water Corporation - One Member Limited Liability Company - state shareholder holding 53.15% (equivalent to 4,974,700 shares);
 - + N.T.P Trading Company Limited - major shareholder holding 20.82% (equivalent to 1,948,689 shares);
 - + Vikki Digital Bank One Member Limited Liability Company - major shareholder holding 10% (equivalent to 936,000 shares);
 - + Mr. Ho Le Minh - major shareholder holding 8.87% (equivalent to 830,550 shares).
- **The remaining 273 shareholders** hold **7.16%** of the total voting shares.

2. Thus, the shareholder structure (according to the notice of shareholders finalization dated December 31, 2025) of Ben Thanh Water Supply Joint Stock Company **no longer meets the conditions** prescribed in Point a Clause 11 Article 1 of Law No. 56/2024/QH15 dated November 29, 2024, amending and supplementing Clause 1 Article 32 of the Law on Securities No. 54/2019/QH14 dated November 26, 2019, specifically: **does not ensure having at least 10% of voting shares held by at least 100 non-major shareholders.**

Ben Thanh Water Supply Joint Stock Company commits to continuing to fully perform the obligations of a public company according to current laws until receiving official notification from the State Securities Commission regarding the cancellation of public company status.
