

**REGULATION ON CANDIDACY - NOMINATION - APPOINTMENT OF
ADDITIONAL MEMBERS OF THE BOARD OF DIRECTORS OF DAKLAK
WATER SUPPLY JOINT STOCK COMPANY FOR THE TERM 2024 – 2028
BY COLLECTING SHAREHOLDERS' OPINIONS IN WRITING**

**Chapter I
GENERAL PROVISIONS**

Article 1. Scope of application

This Regulation is established to specify the principles and methods for the candidacy - nomination - appointment of members of the Board of Directors of Daklak Water Supply Joint Stock Company for the term 2024 – 2028 in the form of collecting shareholders' opinions in writing.

Article 2: Application Purpose

This Regulation details the order and procedures for Shareholders to conduct nominations, candidacy, and other related matters within the scope of application stated in Article 1.

Article 3: Subjects of application

The Regulation shall apply to all shareholders holding voting shares according to the list provided by Viet Nam Securities Depository and Clearing Corporation (VSDC).

**CHAPTER II
REGULATIONS ON ELECTION OF MEMBERS OF THE BOARD OF
DIRECTORS FOR THE TERM 2024-2028**

Article 4. Quantity and standards of members of the Board of Directors

4.1 The General Meeting of Shareholders ("GMS") shall appoint one (01) additional member of the Board of Directors for the term 2024 – 2028.

4.2 Standards and Conditions for Board of Directors Members:

Members of the Board of Directors shall satisfy the standards for being a BOD member as stipulated in Article 155 of Law on Enterprises 2020 and the Regulation, specifically as follows:

- a) Not being a subject specified in Clause 2, Article 17 of Law on Enterprises 2020;
- b) Possessing professional qualifications and experience in business management or in the fields, industries, or business lines of the company and is not necessarily a shareholder of the company, unless otherwise stipulated in the Articles of Association of the Company;
- c) A member of the Board of Directors of the company may concurrently be a member of the Board of Directors of another company;

d) May concurrently be a member of the Board of Directors or Members' Council of a maximum of 05 other companies;

e) Other standard conditions as stipulated by the Law on Enterprises, the Securities Law, and the Articles of Association of the Company.

Article 5. Rights to nominate and self-nominate as a member of the Board of Directors:

5.1 Shareholders or groups of shareholders owning 10% or more of the total number of ordinary shares have the right to nominate persons to the Board of Directors in accordance with the current Law on Enterprises and the Company's Articles of Association. Shareholders or groups of shareholders holding:

a) From 10% to less than 30% of voting shares may nominate a maximum of two candidates;

b) From 30% to less than 40% of voting shares may nominate a maximum of three candidates;

c) From 40% to less than 50% of voting shares may nominate a maximum of four candidates;

d) From 50% to less than 60% of voting shares may nominate a maximum of five candidates;

e) From 60% to less than 70% of voting shares may nominate a maximum of six candidates;

f) From 70% to less than 80% of voting shares may nominate a maximum of seven candidates;

g) From 80% to less than 90% of voting shares may nominate a maximum of eight candidates.

Self-nominated persons and nominated persons (hereinafter collectively referred to as candidates) shall submit valid and timely candidacy dossiers as prescribed.

5.2 In case the number of candidates for the Board of Directors through nomination is still insufficient, the remaining candidates shall be appointed by the incumbent Board of Directors.

Article 6. Dossier for Nomination and Candidacy for Election as a Member of the Board of Directors

6.1 Dossiers of candidacy and candidate nomination for election to the Board of Directors include:

a. Application for Candidacy or Application for Candidate Nomination for the Board of Directors;

b. Curriculum Vitae self-declared by the candidate with a photo attached;

c. A valid copy of the ID Card / Citizen Identity Card / Passport;

d. A valid copy of the Permanent Household Registration Book (or long-term temporary residence registration certificate);

e. Valid copies of diplomas, degrees, and certificates confirming educational level and professional qualifications;

f. Power of Attorney and/or Group Meeting Minutes (if the candidate is authorized for nomination by a group).

CHAPTER III

ELECTION OF MEMBERS OF THE BOARD OF DIRECTORS FOR THE (2024–2028) TERM

Article 7. Selection of candidates

Based on the nomination and self-nomination forms submitted by shareholders and groups of shareholders, and the accompanying dossiers of the candidates, the Board of Directors shall prepare the list of candidates who fully satisfy the prescribed eligibility conditions for election as members of the Board of Directors.

Article 8. Principles

The supplemental appointment of members of the Board of Directors shall be conducted in accordance with the following principles:

- Compliance with the applicable laws on enterprises in Viet Nam;
- Ensuring transparency, democracy, and the lawful rights and interests of all shareholders.

Article 9. Eligible persons

All shareholders holding shares carrying voting rights, as shown in the list provided by the Vietnam Securities Depository and Clearing Corporation (VSDC), shall be eligible.

Article 10. Form and method

10.1 Form: Written consultation of shareholders.

10.2 Method:

- Each shareholder shall be sent one (01) consultation ballot.

- The consultation ballot shall be sent by a method that ensures delivery to the registered address of each shareholder.

- As the number of candidates is equal to the number of Board of Directors members to be additionally appointed, the election of members of the Board of Directors shall be conducted by the voting method (Approve, Disapprove, No Opinion).

10.3 How to complete the consultation ballot:

- The shareholder selects one (01) of the three (03) options (Approve, Disapprove, No Opinion) by marking (X).

10.4 A valid consultation ballot is a ballot that satisfies all of the following conditions:

- The ballot is cast for a candidate whose name appears in the list of candidates approved by the Board of Directors.

- It bears the shareholder's confirming signature on the consultation ballot;

- It does not fall within the cases specified in Article 10.5 of this Regulation.

10.5 An invalid consultation ballot is a ballot that falls into one of the following cases:

- A ballot not issued by the Company;

- A ballot containing erasures, deletions, amendments, or additions not made in accordance with the regulations;

- A ballot on which two (02) or more boxes are marked for the matter subject to consultation. Where all three boxes (Approve, Disapprove, No Opinion) for the matter subject to consultation are not marked, but the shareholder still signs and clearly writes his/her full name, or the document bears the signature and name of the legal representative and the seal (if the shareholder is an organization), it shall be deemed as No Opinion.

- A ballot containing additional entries or a name written incorrectly, or a name not included in the list of candidates approved by the Board of Directors prior to voting;

- A ballot not signed by the shareholder;

- The envelope containing the ballot has been opened prior to ballot verification;

- A ballot returned to the Company after the prescribed deadline.

10.6 Procedure

- The Company's supplemental appointment of members of the Board of Directors shall be carried out by the voting method.

- After the deadline for shareholders to return the consultation ballots to the Company, the Board of Directors shall organize the vote counting.

Article 11. Vote counting

11.1 The Board of Directors shall appoint a Vote Counting Committee and organize the vote counting under the supervision of the Company's Supervisory Board, in accordance with the following provisions:

- Verifying the validity of the consultation ballots;

- Examining each consultation ballot in turn and recording the vote counting results;

- Calculating and excluding the number of shares not entitled to voting held by shareholders without voting rights (if any);

- All completed consultation ballots shall be retained at the Company's head office.

11.2 The Vote Counting Committee shall be responsible for preparing the Vote Counting Minutes to summarize the results of the election of members of the Board of Directors.

Article 12. Adoption of the General Meeting of Shareholders' Resolution on the election of members of the Board of Directors

The adoption of the Resolution on the election of members of the Board of Directors by the voting method shall be determined as follows:

- A candidate shall be elected if approved by shareholders holding more than 50% of the total voting shares, in accordance with the Company's Charter and applicable laws.

Article 13. Validity

This Regulation shall take effect and apply to the nomination, self-nomination, and appointment of members of the Board of Directors for the 2024–2028 term through written consultation of shareholders.
