- Pursuant to the current Charter of Bac A Commercial Joint Stock Bank;
- Pursuant to the current Regulations on the organization and operation of the Board of Directors;
- Pursuant to Official Dispatch No.66/KV1-QLGS1 dated 09/01/2026 of the State Bank of Vietnam, Region 1 Branch, regarding the approval of the change of location for the headquarters of Bac A Commercial Joint Stock Bank - Thai Ha Branch - Yen Xa Transaction Office;

HEREBY DECIDE:

Article 1. Change of location for the headquarters of Bac A Commercial Joint Stock Bank - Thai Ha Branch - Yen Xa Transaction Office ("Yen Xa Transaction Office"). Specifically as follows:

- **Old location:** Lot L3, Land Use Rights Auction Area, Ha Dong Ward, Hanoi City.
- **New location:** 1st Floor, Lot B19, Land Use Rights Auction Area, Ha Dong Ward, Hanoi City.

Article 2. The Board of Directors assigns the Executive Board of BAC A BANK to

Direct/organize the implementation of tasks related to the change of the headquarters location and name of the Yen Xa Transaction Office at competent state authorities and carry out other necessary procedures to ensure compliance with BAC A BANK's internal regulations and current laws.
