SUMMARY OF KEY TERMS AND CONDITIONS OF THE CONTRACT

1. Contracting parties:
 - Party A (Employer): Binh Son Refining and Petrochemical Joint Stock Company (BSR)
 - Party B (Contractor): PetroVietnam Engineering Consultancy Joint Stock Company (PVE)
2. Scope of work: Provision of services for evaluation to upgrade of material for the E-1111A~L heat exchanger in unit CDU under Purchase Order No. 861/1100003947/ĐH-KTCN-TAC dated 10 November 2025.
3. Effectiveness of the contract:

The Contract shall take effect from the date of signing.
4. Contract performance period:

75 days from the date of signing.
5. Contract value, inclusive of 8% Value Added Tax (VAT), is VND **497,134,584**
(In words: Four hundred ninety-seven million one hundred thirty-four thousand five hundred eighty-four Vietnamese dong).
