PTSC Quang Ngai Joint Stock Company, stock code PQN, provides the following supplementary explanation for discrepancies in the financial statement for Q4 2025 compared to the same period last year:

The after-tax profit in the financial statement for Q4 2025 is VND 8,618 million, a increase of VND 3,092 million compared to Q4 2024 (equivalent to a 55,96% increase). The primary reason for this change was the increase in revenue during the period (mainly related to industrial construction and installation services), which resulted in a significant improvement in the Company's gross profit margin compared with the same period in 2024.
