*The Parties agree to execute Appendix No. 01 to the Contract for the purchase and sale of the Barge convoy No. 01/2026/HDMB/VTT-PT dated January 12, 2026, with the following contents:*

**ARTICLE 1::** Amendment to Article 2 of the Contract for the purchase and sale of the Barge convoy No. 01/2026/HDMB/VTT-PT, as follows:

**Selling price of the barge convoy:**

The selling price excludes value-added tax (VAT) and the quantity of fuel oil (DO) remaining at the time of handover.

The selling price includes lubricants and materials remaining on the Barge convoy at the time of handover.

**ARTICLE 2:** Replacement of Article 3 of the Contract for the purchase and sale of the Barge convoy No. 01/2026/HDMB/VTT-PT, as follows:

The Parties agree to purchase and sell the aforesaid “VTT 02” barge convoy under the outright sale method (on the condition that the technical status of equipment is in normal operation, with valid Certificates of technical safety and environmental protection and inland waterway vehicle registration). This Contract shall serve as the legal basis for carrying out procedures for the transfer of ownership between the Parties.

Selling price (exclusive of VAT): 43,400,000,000 VND

(In words: Forty-three billion four hundred million dong).

Value-added tax (VAT) shall be determined in accordance with State regulations in force at the time of invoice issuance.

The remaining value of fuel oil (DO) on the barge convoy shall be determined based on the actual quantity handed over and the unit price published by Vietnam National Petroleum Group at the time of handover.

**ARTICLE 3: Other provisions**

All other contents not mentioned in this Appendix shall remain unchanged in accordance with signed contents in the Contract for the purchase and sale of the Barge convoy No. 01/2026/HDMB/VTT-PT dated January 12, 2026.

**ARTICLE 4: Implementation provisions**

This Appendix to the contract for the purchase and sale of the Barge convoy shall take effect from the date of signing and constitutes an integral and inseparable part of the Contract for the purchase and sale of the Barge convoy No. 01/2026/HDMB/VTT-PT dated January 12, 2026 entered into between the Parties.

This Appendix is made in 08 (eight) originals of equal legal validity; each Party retains 04 (four) originals for implementation.
