3. Supervisory activities of the Board of Controllers regarding the Board of Directors, Board of Management, and Shareholders:

- *Activities of the Board of Directors (BOD)*

+ The BOD directed the implementation of the 2025 production and business plan approved by the Annual General Meeting of Shareholders.

+ The BOD effectively performed its role in directing, supervising, and supporting the Board of Management and functional Departments/affiliated Units of PV GAS LPG in production and business activities.

+ The BOD directed the implementation of restructuring tasks at PV GAS LPG.

- *Activities of the Board of Management (BOM):*

+ The Board of Management deployed and directed functional departments and affiliated units to coordinate and strictly implement the Resolutions/Decisions of the BOD, while striving to overcome difficulties and adopting rigorous executive measures to fulfill the production and business plan.

+ The Board of Management managed and operated production and business activities in accordance with the decentralization between the BOD and the Board of Management.

+ The Board of Management strengthened management, assessment, classification, and measures to recover and handle debts, inventories, and unnecessary assets at units to minimize risks, limit capital misappropriation affecting capital balancing, and cash flow for production and business activities.

+ The Board of Management implemented restructuring tasks at PV GAS LPG.
