- Pursuant to the Enterprise Law No. 59/2020/QH14 dated June 17, 2020, and its amendments and supplements;
- Pursuant to the Charter on Organization and Operation of Sunshine Group Joint Stock Company ("the Company")
- Pursuant to the Minutes of the Board of Directors' meeting No.: *04*/2026/SSG/BBH-HĐQT dated January *04*, 2026.

RESOLVES

Article 1: Approval of the policy on the execution of a Service Contract for organizing the Year End Party 2025 between the Company and ODE Media and Entertainment Group Joint Stock Company, with details as follows:

1. Information of ODE Media and Entertainment Group Joint Stock Company ("ODE"):

- Tax code: 0107602021.

2. Main contents:

- Contract scope: ODE shall provide Year End Party 2025 event organization services to the Company.
- Estimated total contract value: VND 3,500,000,000 (inclusive of VAT). Detailed items and unit prices shall be agreed upon by the parties and set out in an appendix to be signed prior to the event, which shall form an integral and inseparable part of this Contract. The final settlement value shall be determined based on the actual volume of work performed by ODE and accepted in writing by duly authorized representatives of both parties.
- Implementation period: Year 2026.

3. Related-party relationship with the Company:

Mr. Cao Phi Hung – Deputy General Director of the Company – is a Member of the Board of Directors of ODE; Mr. Dinh Chi Hieu – Deputy General Director of the Company – is the Chairman of the Board of Directors of ODE.



Article 2. Implementation of works:

- To assign/authorize the Chairman of the Board of Directors / General Director of the Company to negotiate, decide on the contents, approve, and execute the Contract and any appendices thereto (if any) in accordance with the contents set out in Article 1 as approved by the Board of Directors.
- The Chairman of the Board of Directors / General Director of the Company is entitled to further delegate such authorized powers to another individual for the performance of the authorized matters.

Article 3: This Resolution takes effect from the date of signing. Members of the Board of Directors, the Executive Board, relevant departments, and individuals are responsible for implementing this Resolution.
