Pursuant to the Law on Enterprises No. 59/2020/QH14 dated June 17, 2020;

Pursuant to the Charter on Organization and Operation of Nha Be Water Supply Joint Stock Company;

Pursuant to the Internal Regulations on Governance of Nha Be Water Supply Joint Stock Company;

Pursuant to the Minutes of the Board of Directors Meeting No. 31/BB-CNNB-HDQT dated February 06, 2026, of the Board of Directors of Nha Be Water Supply Joint Stock Company,

RESOLVED:

Article 1. Approve the production - business - financial results of 2025, together with the Financial Statements of Quarter 4 of 2025 and directions and tasks for 2026. The results of implementation of key indicators in 2025 are as follows: water production volume is 71,378 thousand m³, reaching 98.45% of the plan; water revenue is 901.99 billion VND, reaching 100.20% of the plan; total revenue is 916.07 billion VND, reaching 100.78% of the plan; profit before tax is 42.53 billion VND, reaching 105.00% of the plan; profit after tax is 31.88 billion VND, reaching 100.24% of the plan (*attached Annex 1: Results of production - business - finance in 2025*).

Article 2. Approve the adjustment of the wholesale unit price of clean water in 2025 between the Company and Saigon Water Corporation regarding the water volume exploited on the assets (pipeline routes) of the Company to 7,391.67 VND/m³, replacing the unit price of 7,276.70 VND/m³.

The decision and implementation of the above arising items must ensure the following principles:

1. Directly serving production and business activities, operation of the water supply system, or meeting urgent requirements of the Company;
2. Fully complying with current legal regulations and internal regulations and rules of the Company;
3. Ensuring efficiency, savings, and suitability with the Company's financial capabilities;
4. Not affecting the financial situation, solvency, and fulfillment of financial obligations of the Company.

Article 5. Approve the Basic Construction Investment Plan for 2026 as proposed by the Company Director in Proposal No. 383/CNNB-TCHC dated February 04, 2026.

Article 6. Approve the renaming of the **Water Supply Operation Management Department** to the **Customer Service Department** as proposed by the Company Director in Proposal No. 170/TTr-CNNB dated January 16, 2026.

Article 7. Approve the plan to organize the 2026 Annual General Meeting of Shareholders as proposed by the Chairman of the Board of Directors in Proposal No. 174/TTr-CNNB dated January 16, 2026.

- Record date for the list of shareholders entitled to attend the meeting: March 20, 2026;

3. Supplement the regulation in this Article to the regulation on rewards for water loss control of the Company. The Director is responsible for amending and supplementing the regulation and organizing implementation according to regulations.

Article 9. The Company Director is responsible for implementing the contents approved by the Board of Directors in this Resolution./.
