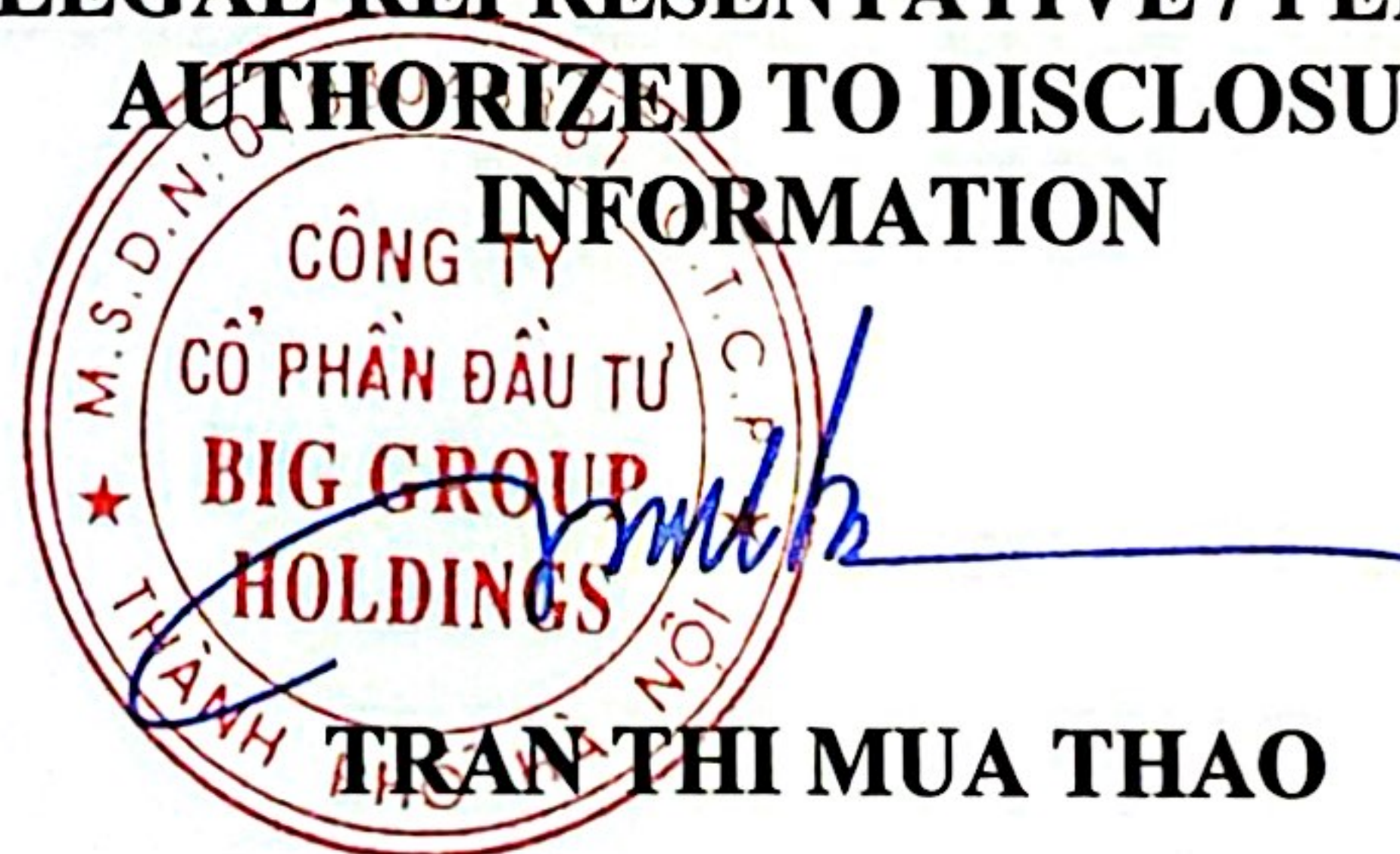

RESOLUTION OF THE BOARD OF DIRECTORS  
BIG GROUP HOLDINGS INVESTMENT JOINT STOCK COMPANY

- Pursuant to the Law on Enterprises and its guiding documents;
- Pursuant to the Charter of Big Group Holdings Investment Joint Stock Company;
- Pursuant to the Minutes of the Board of Directors No. 07a/2026/BIG/BBH-HĐQT dated 25/3/2026;

RESOLUTION:

**Article 1.** Approve the capital contribution by Big Group Holdings Joint Stock Company to establish a subsidiary operating in the beverage service sector with the following details:

- Expected name of the subsidiary:
  - Vietnamese name: **CÔNG TY CỔ PHẦN BIG FNB**
  - English name: **BIG FNB JOINT STOCK COMPANY**
  - Abbreviated name: **BIG FNB**
- Headquarters address: 95 Vo Thi Sau, Xuan Hoa Ward, Ho Chi Minh City, Vietnam.
- Main business line: Beverage services.
- Charter capital: 10,000,000,000 VND (Ten billion Vietnamese Dong).
- Capital contribution ratio:
  - Big Group Holdings Joint Stock Company contributes 98% of the charter capital, equivalent to 9,800,000,000 VND (Nine billion eight hundred million Vietnamese Dong).
  - Other shareholders contribute a total of 2% of the charter capital, equivalent to 200,000,000 VND (Two hundred million Vietnamese Dong).
- Assignment of duties: Appoint Mr. HUYNH GIA HUY as the Legal Representative of Big FNB Joint Stock Company.

**Article 2.** Authorize the Legal Representative of Big Group Holdings Joint Stock Company to implement all procedures related to the establishment of the subsidiary as mentioned in Article 1 in accordance with the law and requirements of competent State authorities, including adjusting detailed business lines; adjusting or changing excluded business activities within business codes as required by competent State authorities and in compliance with legal regulations.





**Article 3.** This Resolution shall take effect from the date of its signing.
