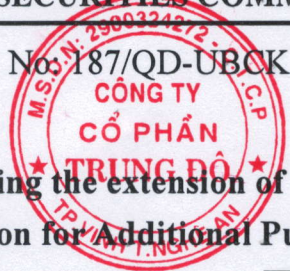

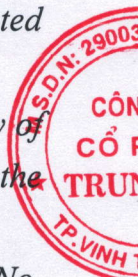

DECISION:

Article 1. Approval for the extension of the Public Offering Share distribution period for:
