2. Content of published information:

Dak Lak Water Supply Joint Stock Company would like to explain the change of 10% or more in after-tax profit in the audited financial statements for the fiscal year ending December 31, 2025, compared to the same period of the previous year, specifically as follows:

The after-tax profit in the audited financial statements for the fiscal year ending December 31, 2025, was VND 79,039,679,626, compared to VND 50,963,244,400 in the same period of the previous year. This represents an increase of VND 28,076,435,226 (equivalent to a 55.09% increase). This is due to an increase in revenue in 2025 compared to 2024 of VND 47,385,840,043 (equivalent to a 16.17% increase), and also an increase in the volume of commercial water supplied to customers due to higher customer demand compared to the same period of the previous year. Meanwhile, total expenses for this period increased by VND

15,349,178,353 compared to the same period last year (equivalent to a 6.50% increase). The rate of increase in expenses was lower than the rate of increase in revenue, leading to a pre-tax profit in 2025 of VND 32,036,661,690 (equivalent to a 56.33% increase) compared to the same period last year. After calculating corporate income tax payable, after-tax profit reached VND 79,039,679,626, an increase of VND 28,076,435,226 (equivalent to a 55.09% increase), resulting in an after-tax profit change of 10% or more compared to the report of the same period last year.
