Hoang Ha Joint Stock Company would like to provide an explanation for the reasons behind the after-tax profit in the separate and consolidated financial statements for in 2025 showing a loss and being lower than that of in 2024, in accordance with Circular No. 155/2015/TT-BTC dated October 06, 2015, issued by the Ministry of Finance, providing guidelines on information disclosure in the securities market, as follows:

- After-tax profit in the separate financial statement for in 2025: (67.411.686.414) VND.
- After-tax profit in the separate financial statement for in 2024: (33.023.917.340) VND.

And:

- After-tax profit in the consolidated financial statement for in 2025: (67.447.967.761) VND.
- After-tax profit in the consolidated financial statement for in 2024: (33.302.151.577) VND.

The after-tax profit in the separate and consolidated financial statements for in 2025 shows a loss and is lower than that of in 2024, primarily due to the following reasons:

+ Following the prolonged COVID-19 pandemic, the operations of the transportation sector have not yet fully recovered to their previous levels. Revenue remains low, while the company's costs, including fixed asset depreciation, remain unchanged.

+ Disguised transportation services are growing

+ There was no revenue from real estate brokerage activities.

The above is the explanation regarding the after-tax profit in the separate and consolidated financial statements for in 2025 showing a loss and being lower than that of in 2024.
