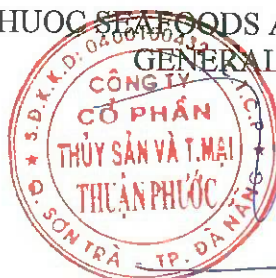

**DECISION**  
**On Administrative Sanctioning**

**DIRECTOR OF DA NANG CITY TAX DEPARTMENT**

Pursuant to Articles 57, 68, 70, 78, and 85 of the Law on Handling of Administrative Violations (amended and supplemented in 2020);

Pursuant to the Law on Tax Administration No. 38/2019/QH14 dated June 13, 2019; Law No. 56/2024/QH15 dated November 29, 2024 and guiding documents for implementation;

Pursuant to Decree No. 68/2025/ND-CP dated March 18, 2025 of the Government amending and supplementing a number of articles of Decree No. 118/2021/ND-CP dated December 23, 2021 detailing a number of articles and measures for implementation of the Law on Handling of Administrative Violations;

Pursuant to Decree No. 125/2020/ND-CP dated October 19, 2020 of the Government regulating administrative sanctions in the fields of tax and invoices;

Pursuant to Decision No. 1376/QĐ-CT dated June 30, 2025 of the Director of the Tax Department stipulating the functions, duties, powers, and organizational structure of provincial and municipal Tax Departments under the Tax Department;

Pursuant to the tax inspection record dated March 25, 2026 between the Head of the inspection team under Decision No. 422/QĐ-DAN dated March 10, 2026 of the Director of Da Nang City Tax Department and the legal representative of Thuan Phuoc Seafood and Trading Joint Stock Company;

Pursuant to Decision No. 69/QĐ-GQXP-DAN dated January 12, 2026 of the Director of Da Nang City Tax Department on authorization of administrative sanctioning powers to Deputy Directors of Da Nang City Tax Department;

**DECIDES :**

**Article 1.**

1. To impose administrative sanctions on the following organization:

Thuan Phuoc Seafoods and Trading Corporation

Head office address: Lot No. 02, Bui Quoc Hung Street, Tho Quang Seafood Service Industrial Zone, Son Tra Ward, Da Nang City.

Enterprise registration number: 0400100432.

Enterprise Registration Certificate No. 0400100432 issued by the Da Nang Department of Finance on June 29, 2007; amended for the 10th time on July 9, 2025.

Legal representative: Nguyen Thi Phi Anh; Gender: Female.

Title: General Director.

2. Administrative violation committed: Making incorrect tax declarations leading to an increase in the value-added tax (VAT) amount requested for refund but not yet refunded for the tax period of October 2025, in accordance with Clause 3, Article 16 and Clause 3, Article 12 of Decree No. 125/2020/ND-CP dated October 19, 2020 of the Government.

3. As prescribed in Clause 3, Article 16 and Clause 3, Article 12 of Decree No. 125/2020/ND-CP dated October 19, 2020 of the Government.

4. Aggravating circumstances: None.

5. Mitigating circumstances: None.



6. Sanctioning forms and remedial measures are applied as follows:

- a) Main sanction: A monetary fine of VND 6,500,000 (in words: six million five hundred thousand Vietnamese dong) for the act of making incorrect declarations leading to an increase in the value-added tax (VAT) amount requested for refund but not yet refunded, as prescribed in Clause 3, Article 16 and Clause 3, Article 12 of Decree No. 125/2020/ND-CP dated October 19, 2020 of the Government.
- b) Additional sanctions: None.
- c) Remedial measures: None.

## **Article 2.**

This Decision takes effect from the date of signing.

## **Article 3.**

This Decision is sent to:

1. Assign Ms. Nguyen Thi Phi Anh as the representative of the sanctioned organization specified in Article 1 of this Decision for implementation.

Thuan Phuoc Seafoods and Trading Corporation, as stated in Article 1, must strictly comply with this sanctioning Decision. If, after the prescribed time limit, the Company fails to voluntarily comply, enforcement measures shall be taken in accordance with the law; and for each day of late payment of the fine, the Company shall pay an additional 0.05% calculated on the total unpaid fine amount.

a) Thuan Phuoc Seafoods and Trading Corporation, as stated in Article 1, shall pay the fine at Transaction Office GD1 of the State Treasury of Region XIII or transfer the fine to a commercial bank where the State Treasury of Region XIII has opened an account, according to the state budget payment details as follows:

- Account No.: 7111
- Code of the sanctioning authority: 1054323
- Chapter code: 554
- Economic content code (sub-item): 4254 (administrative violation fine)

within 10 days from the date of receipt of this Decision.

b) Thuan Phuoc Seafoods and Trading Corporation has the right to lodge complaints or initiate an administrative lawsuit against this Decision in accordance with the law.

2. Send to the State Treasury of Region XIII for collection of the fine.

3. Send to the following divisions: Inspection Division No. 3; Enterprise Management and Support Division No. 3 for implementation of this Decision.
