NOTICE

Regarding the failure to meet the conditions for a Public Company

To: - The State Securities Commission of Vietnam;
- The Hanoi Stock Exchange.

Pursuant to the Law on Securities No. 54/2019/QH14 dated November 29, 2019, as amended and supplemented by a number of articles in Law No. 56/2024/QH15 dated November 29, 2024, of the National Assembly;

Pursuant to Circular No. 96/2020/TT-BTC dated November 16, 2020, guiding information disclosure in the securities market;

Pursuant to Circular No. 19/2025/TT-BTC dated November 16, 2025, stipulating the registration of public companies, revocation of public company status, and reporting on audited contributed charter capital;

Long An Water Supply Sewerage Joint Stock Company (Code: LAW) hereby reports to the State Securities Commission of Vietnam and the Hanoi Stock Exchange on the Company's failure to meet the conditions for a public company as follows:

Based on the consolidated list of the Company's securities holders prepared by Vietnam Securities Depository and Clearing Corporation - Ho Chi Minh City Branch on March 31, 2025, Long An Water Supply Sewerage Joint Stock Company (Lawaco) has 147 shareholders, including:

- Major shareholders include 02 shareholders holding 98.06% of the total voting shares, specifically:

+ Tay Ninh Provincial People's Committee owns 60% (equivalent to 7,320,000 shares);

+ Binh Duong Water - Environment Corporation - Joint Stock Company owns 38.06% (equivalent to 4,643,740 shares);

- The remaining 145 shareholders, who are not major shareholders, own 1.94% of the total voting shares.

Thus, Lawaco has not met the conditions for a public company as stipulated in Point a, Clause 1, Article 32 of the Law on Securities No. 54/2019/QH14 dated November 26, 2019, as amended and supplemented in Point a, Clause 11, Article 1 of Law No. 56/2024/QH15 dated November 29, 2024, specifically: *at least 10% of the voting shares are not held by at least 100*



investors who are not major shareholders.

Lawaco will continue to work with major shareholders, and simultaneously report and propose solutions to the owner entity to ensure compliance with current regulations. During this period, Lawaco commits to continuing to fully perform the obligations of a public company as stipulated.

Lawaco respectfully submits this report to the State Securities Commission of Vietnam and the Hanoi Stock Exchange.

This Notice replaces Notice No. 22/TB-LAW dated March 6, 2026 of Long An Water Supply Sewerage Joint Stock Company./.
