2. To make approval and sign-off all documents, dossiers, contracts relating to warrant offering, including: Prospectus, Offering Notice, reports, documents, related to the covered warrant offering to comply with applicable laws.
3. To make decision on collateral value, select custodian banks, and sign-off contracts and documents with selected custodian banks for receipt and depository of collaterals for payment and to implement other tasks in accordance with applicable laws.
4. To make decision and implement all procedures, sign-off all necessary documents, dossiers as required by the laws for warrant depository registration at Vietnam Securities Depository and Clearing Corporation and warrant listing on Ho Chi Minh Stock Exchange, including dossiers for adjustment (if any)

Article 4. This Resolution shall take effect from the signing date. Members of the Board of Directors, the Board of Management, related departments and individuals shall take responsibility for the implementation of this Resolution.
