

DECISION
On Administrative Sanctioning

DIRECTOR OF DA NANG CITY TAX DEPARTMENT

Pursuant to Articles 57, 68, 70, 78, and 85 of the Law on Handling of Administrative Violations (amended and supplemented in 2020);

Pursuant to Decree No. 125/2020/NĐ-CP dated October 19, 2020 of the Government on administrative penalties for violations related to tax and invoices;

Pursuant to Decree No. 118/2021/NĐ-CP dated December 23, 2021 of the Government detailing a number of articles and measures for implementation of the Law on Handling of Administrative Violations;

Pursuant to Decree No. 68/2025/NĐ-CP dated March 18, 2025 of the Government amending and supplementing a number of articles of Decree No. 118/2021/NĐ-CP dated December 23, 2021 of the Government detailing a number of articles and measures for implementation of the Law on Handling of Administrative Violations;

Pursuant to Decree No. 310/2025/NĐ-CP dated December 02, 2025 of the Government amending and supplementing a number of articles of Decree No. 125/2020/NĐ-CP dated October 19, 2020 of the Government on administrative penalties for violations related to tax and invoices;

Pursuant to Decision No. 1376/QĐ-CT dated June 30, 2025 of the Director of the Tax Department stipulating functions, duties, powers and organizational structure of provincial and municipal Tax Departments under the Tax Department;

Pursuant to the Record of Administrative Violation in Tax No. 08/BB-VPHC dated March 31, 2026;

Pursuant to Decision No. 69/QĐ-GQXP-DAN dated January 12, 2026 of the Head of Da Nang Tax Department on authorization of administrative sanctioning powers to Deputy Heads of Da Nang Tax Department.

DECISION

Article 1.

To impose administrative penalties on the following organization:

1. Thuan Phuoc Seafoods and Trading Corporation

Address: Lot 02, Bui Quoc Hung Street, Seafood Service Industrial Park, Son Tra Ward, Da Nang City.

Tax code: 0400100432, issued by the Department of Planning and Investment of Da Nang City (now the Department of Finance of Da Nang City) on June 29, 2007.

Legal representative: Nguyen Thi Phi Anh. Gender: Female.

Position: Director.

2. Administrative violation committed : The Company issued 01 invoice not at the correct time, but it did not lead to a delay in the fulfillment of tax obligations.

The Company violated Clause 6, Article 1 of Decree No. 70/2025/NĐ-CP dated March 20, 2025 of the Government. Details of the VAT invoice: Series: C25TTP, No.: 1277, issued on November 18, 2025.

3. Legal basis : As prescribed in Clause 3, Article 24 of Decree No. 125/2020/NĐ-CP dated October 19, 2020 of the Government.

4. Aggravating circumstances: None.

5. Mitigating circumstances: None.

6. Sanctions and remedial measures applied as follows:

a) Main penalty: Fine.

Fine amount: VND 4,000,000

(In words: Four million Vietnamese dong).

Fine level (=) average fine level within the penalty bracket of VND 4,000,000 × (multiplied by) 01 invoice.

b) Additional penalties: None.

c) Remedial measures: None.

Article 2.

This Decision takes effect from the date of signing.

Article 3.

1. Assigning Ms. Nguyen Thi Phi Anh as the representative of Thuan Phuoc Seafoods and Trading Corporation to implement this Decision.

Thuan Phuoc Seafoods and Trading Corporation must strictly comply with this sanctioning Decision. If the Company fails to voluntarily comply within the prescribed time limit, enforcement measures shall be taken in accordance with the law, and for each day of late payment, the violating organization must pay an additional 0.05% calculated on the total unpaid fine amount.

a) Thuan Phuoc Seafoods and Trading Corporation shall pay the fine to the State Treasury of Region XIII – Transaction Office No. 1 according to the state budget payment details as follows:

- State budget account: 7111
- Decision-issuing authority code: 1054323
- Chapter: 554
- Economic content code (sub-item): 4254

Within 10 days from the date of receipt of this Decision.

b) Thuan Phuoc Seafoods and Trading Corporation has the right to lodge complaints or initiate administrative lawsuits against this Decision in accordance with the law.

2. To send to the State Treasury of Region XIII – Transaction Office No. 1 for the collection of the fine.

3. To send to the Division No. 3 for Enterprise Management and Support under the Da Nang Tax Department for implementation./.
