NOTICE

Re the implementation of tax debt collection measures against taxpayers

Pursuant to the Law on Tax Administration dated June 13, 2019;

Pursuant to Decree No. 126/2020/ND-CP dated October 19, 2020 of the Government detailing several articles of the Law on Tax Administration;

Pursuant to Notice No. 19590/TB-HCM-KDT dated October 08, 2025, of the Ho Chi Minh City Tax Department regarding the notification of tax debt;

The Ho Chi Minh City Tax Department hereby notifies the tax debt amount to Mr./Ms. Mai Ngoc Dinh, the legal representative of:

Taxpayer: UDCONS Construction Investment Corporation (Company); Tax Identification Number: 3500101308.

After this document is issued, if the taxpayer fails to pay or fails to prove that the above debts have been paid into the state budget, the Tax authority will implement tax debt collection measures as follows:

1. Issuing an enforcement decision by deducting money from the taxpayer's account (currently in progress);
2. Issuing an enforcement decision by deducting a portion of salary or income (for individuals);
3. Issuing an official dispatch requesting the Customs authority to suspend procedures for exported and imported goods;
4. Issuing an enforcement decision and a notice on the suspension of invoice usage;
5. Distraining assets and auctioning distrained assets in accordance with the law to collect tax debts, fines, and late payment interest for the State budget;

6. Collecting money and other assets of the subject of enforcement currently held by other organizations or individuals;

7. Issuing an official dispatch to competent authorities to coordinate the revocation of the Business Registration Certificate, Enterprise Registration Certificate, Establishment and Operation License, Practicing License, etc.;

8. Publicizing information on tax law violations on mass media;

9. Implementing other tax debt collection measures.
