On the termination of branch operations

AIRPORTS CORPORATION OF VIETNAM

- Pursuant to decrees and circulars guiding the implementation of the Law on Enterprises;
- Pursuant to the Charter of Airports Corporation of Vietnam;
- Pursuant to Resolution No. 217/NQ-HĐQT dated April 13, 2026 on the termination of branch operations.

DECIDES

Article 1: To terminate the operation of the branch: Phu Quoc International Airport – Branch of Airports Corporation of Vietnam; Address: Group 2, Duong To Area, Phu Quoc Special Zone, An Giang Province.

- Initial registration: May 16, 2012; 7th amendment: January 8, 2025;

Article 2: Reason for termination: Pursuant to Decision No. 2405/QĐ-BXD dated December 25, 2025 of the Ministry of Construction on the revocation and re-issuance of the airport operation license at Phu Quoc International Airport.

Article 3: This Decision shall take effect from the date of signing.

- Phu Quoc International Airport – Branch of Airports Corporation of Vietnam shall be responsible for performing contracts, settling all debts including tax obligations of the branch, and continuing to employ or fully resolving the lawful rights and interests of employees who have worked at the branch in accordance with the law.

- Mr. Nguyen Minh Dong – Director of Phu Quoc International Airport – Branch of Airports Corporation of Vietnam is assigned to implement this Decision.
