**Re: Insufficient quorum to convene the 2026 Annual General Meeting of Shareholders
(First Meeting)**

To: Shareholders of the Company.

Pursuant to the Law on Enterprises No. 59/2020/QH14 passed by the National Assembly of the Socialist Republic of Vietnam on June 17, 2020;

Pursuant to the Charter of organization and operation of Petroleum Real Estate Joint Stock Company as approved by the General Meeting of Shareholders;

Pursuant to the Report on verification of shareholder eligibility for attendance at the 2026 Annual General Meeting of Shareholders dated April 21, 2026 issued by the Shareholder Eligibility Verification Committee;

On April 21, 2026, in accordance with the announced plan, Petroleum Real Estate Joint Stock Company (PVL) convened the 2026 Annual General Meeting of Shareholders (First Meeting).

However, as of 09:30 a.m. on the same day, after 30 minutes from the scheduled opening time, the total number of attending shareholders and authorized representatives was 03 shareholders, representing 11.936.600 shares, accounting for 23,87% of the total voting shares of the Company.

Accordingly, the Meeting did not satisfy the quorum required to proceed in accordance with the Law on Enterprises and the Company's Charter (*attached with the Report on verification of shareholder eligibility for attendance at the 2026 Annual General Meeting of Shareholders*).

In accordance with regulations, the 2026 Annual General Meeting of Shareholders (Second Meeting) shall be convened within 30 days from April 21, 2026. The Company will organize the 2026 Annual General Meeting of Shareholders (Second Meeting) on April 22, 2026, in accordance with the contents of the Notice of Invitation previously sent to shareholders.

Shareholders are respectfully requested to attend the Meeting to ensure its successful convening.

As at 09:30 a.m. on April 21, 2026, the number of shareholders attending the General Meeting of Shareholders was 03 shareholders (03 attending in person and 0 attending by proxy), representing ownership of 11.936.600 shares, accounting for 23,87% of the total voting shares.
