II. Content of Disclosure:

On May 4th, 2026, Sonadezi Corporation received Judgment No. 10/2026/KDTM-ST dated April 1st, 2026 of the People's Court of Region 1 – Dong Nai, bearing the stamp "Legally Effective Judgment," regarding the dispute over the asset lease contract between Sonadezi Corporation and High Technology JSC, with the main contents as follows:

1. *Acceptance of the claims of Sonadezi Corporation regarding the asset lease contract dispute with High Technology JSC:*

High Technology JSC is ordered to pay Sonadezi Corporation an amount of VND 245,416,624 (two hundred forty-five million, four hundred sixteen thousand, six hundred twenty-four dong). In which, Principal is VND 137,459,984 (one hundred thirty-seven million, four hundred fifty-nine thousand, nine hundred eighty-four dong); Interest is VND 107,956,640 (one hundred seven million, nine hundred fifty-six thousand, six hundred forty dong).

2. *First-instance court fees:*

High Technology JSC must pay VND 12,270,831 (twelve million, two hundred seventy thousand, eight hundred thirty-one dong) in first-instance civil court fees.

Sonadezi Corporation shall be refunded the amount of VND 5,857,671 (five million, eight hundred fifty-seven thousand, six hundred seventy-one dong) paid as advance court fees under Receipt No. 007527 dated November 12th, 2025 issued by the Civil Judgment Enforcement Department of Dong Nai Province.

3. *Rights and obligations regarding enforcement of the Court's judgment*



From the day following the date of the first-instance trial until full enforcement, the judgment debtor must pay interest on the outstanding amount at the interest rate agreed upon by the parties.

If the judgment is enforced under Article 2 of the Law on Civil Judgment Enforcement, the judgment creditor and the judgment debtor may agree on the method of enforcement, request enforcement, voluntarily comply, or be subject to compulsory enforcement in accordance with Articles 6, 7, and 9 of the Law on Civil Judgment Enforcement. The statute of limitations for enforcement shall follow Article 30 of the same Law.

4. Right to appeal: The parties present at the hearing have the right to appeal this judgment within 15 days from the date of pronouncement.
