2. Content of disclosed information:

Binh Duong Producing and Trading Corporation ("**the Corporation**") respectfully reports on the results of stock trading as follows:

The Corporation has received Report No. 21/BC dated April 14, 2026 regarding the results of share transactions conducted by insiders and related persons of insiders of PROTRADE International One Member Company Limited ("**PROTRADE International Company**") - a wholly owned subsidiary of the Corporation. This transaction relates to shares of Binh Duong Garment Joint Stock Company (Stock code: BDG) - an associate of the Corporation.

According to Report No. 21/BC, on April 14, 2026, PROTRADE International Company completed the purchase of 150,000 BDG shares, thereby increasing its ownership to 2.41% of the charter capital of Binh Duong Garment Joint Stock Company. Accordingly, as of April 14, 2026, the total number of shares held by the Corporation in Binh Duong Garment Joint Stock Company is as follows:

- Direct ownership of 11,831,418 shares, representing 47.71% of the charter capital.

- Indirect ownership (through PICL) of 598,675 shares, representing 2.41% of the charter capital.

Pursuant to Article 195 of the Law on Enterprises No. 59/2020/QH14 and Article 8 of Circular No. 202/2014/TT-BTC guiding the preparation and presentation of consolidated financial statements, Binh Duong Garment Joint Stock Company has become a subsidiary of the Corporation through the above direct and indirect shareholdings.
