Ms. Nguyen Thi Quynh Trang - Head of the Shareholder Eligibility Verification Board reported the results of the shareholder qualification examination to attend the meeting as follows:

- Total number of shareholders at the time of closing the list to conduct the General Meeting of Shareholders as of March 30th, 2026 is: 5.161 shareholders, representing 69.329.928 voting shares.;
- As of 8:30 a.m. on May 29th, 2026, the number of shareholders present at the General Meeting was 03.... shareholders, representing 9.201.519..... shares, equivalent to 13,27...% of the total number of voting shares.

Pursuant to the provisions of Law and the Charter of Quang Binh Import and Export Joint Stock Company on the conditions for holding the General Meeting of Shareholders: The second General Meeting of Shareholders is held when the number of shareholders attending the meeting represents 33% or more of the total number of voting shares. Currently, the total number of voting shares of the shareholders attending the meeting is below the regulations threshold, so it is not eligible to hold the 2026 Annual General Meeting of Shareholders of Quang Binh Import-Export Company.
