- 2) The Company's Board of Directors will continue to study and consider the issue of charter capital (increase/or not increase capital) in 2026 as per the contents of the 2026 Annual General Meeting of Shareholders' resolution, which assigned the Board of Directors to report to the State Securities Commission and the Hanoi Stock Exchange in accordance with current regulations.
