Regarding the dossier on notification of the maximum foreign ownership ratio of VINATRANS.



To: Vietnam National Foreign Trade Logistics Joint Stock Company;
Vietnam Securities Depository and Clearing Corporation.

The State Securities Commission (SSC) received Notification No. 269/TB-VIN dated May 20, 2026, regarding the maximum foreign ownership ratio at Vietnam National Foreign Trade Logistics Joint Stock Company (UPCoM: VIN) (the Company) at 0%. The SSC has the following opinions:

1. Organizations and individuals participating in the process of preparing the dossier must be responsible before the law for the legality, accuracy, truthfulness, and completeness of the dossier in accordance with the provisions of Clause 1, Article 11a of the Law on Securities No. 54/2019/QH14 - as amended and supplemented by Law No. 56/2024/QH15, and must be responsible for the results of the review of the maximum foreign ownership ratio at the Company in accordance with the provisions of law.

In the event that the Company has a current foreign ownership ratio exceeding the foreign ownership ratio as prescribed by law, the Company must comply with the provisions of Clause 5, Article 139 of the Government's Decree No. 155/2020/ND-CP detailing the implementation of a number of articles of the Law on Securities (Decree No. 155/2020/ND-CP) as amended and supplemented by Decree No. 245/2025/ND-CP.

2. The SSC requests the Company to fulfill its information disclosure obligations in accordance with the provisions of Clause 2, Article 13 of Circular No. 96/2020/TT-BTC dated November 16, 2020, of the Minister of Finance guiding information disclosure on the securities market as amended and supplemented by Circular No. 68/2024/TT-BTC, Circular No. 18/2025/TT-BTC, and to comply with the provisions of law on foreign ownership ratios on the Vietnamese securities market.

3. Vietnam Securities Depository and Clearing Corporation shall perform the update and adjustment on the system regarding the maximum foreign ownership ratio of the Company in accordance with the provisions of Clause 4, Article 142 of Decree No. 155/2020/ND-CP as amended and supplemented by Decree No. 245/2025/ND-CP.

The SSC hereby notifies the Company, Vietnam Securities Depository and Clearing Corporation, and relevant entities for information and compliance in accordance with the provisions of law./.
