### 3. Reason for the Corrections:

- With respect to Items 1.2 and 1.36 relating to transactions with Binh Duong ACC Investment and Construction Joint Stock Company, and Items 4.1, 4.5, and 4.6 relating to transactions with Nguyen Viet Real Estate Trading and Construction Joint Stock Company, such transactions were conducted in accordance with the proper approval authority. However, in the Company's 2025 Corporate Governance Report, the transaction unit prices were presented based on values inclusive of VAT.
- With respect to Item 1 concerning the transaction with Binh Duong ACC Investment and Construction Joint Stock Company under Quotation No. 08-BBG25-BTN dated May 18, 2025 for the supply and repair works of C19 asphalt concrete pavement, and Item 2 concerning the transaction with An Binh Stone Tile Joint Stock Company regarding the collection of electricity expenses on behalf of An Binh Stone Tile Joint Stock Company, these transactions were also conducted in accordance with the proper approval authority. However, they were inadvertently omitted from the Company's 2025 Corporate Governance Report.

Accordingly, following a review, the Company hereby makes these corrections and amendments to ensure the accuracy of the disclosed information.
