DECISION

Regarding the Amendment of Listing Registration

THE DIRECTOR GENERAL OF THE HO CHI MINH CITY STOCK EXCHANGE

Pursuant to the Law on Securities dated November 26, 2019, and the Law on Amendments and Supplements to several articles of the Law on Securities, Law on Accounting, Law on Independent Audit, Law on State Budget, Law on Management and Use of Public Property, Law on Tax Administration, Law on Personal Income Tax, Law on National Reserve, and Law on Handling of Administrative Violations dated November 29, 2024;

Pursuant to Decree No. 155/2020/ND-CP dated December 31, 2020, of the Government providing detailed regulations for the implementation of several articles of the Law on Securities dated November 26, 2019;

Pursuant to Decision No. 02/QĐ-HDTV dated June 30, 2021, of the Member Council of the Vietnam Stock Exchange regarding the establishment of the Ho Chi Minh City Stock Exchange;

Pursuant to Decision No. 07/QĐ-HDTV dated July 09, 2021, of the Member Council of the Vietnam Stock Exchange on the issuance of the Charter on Organization and Operation of the Ho Chi Minh City Stock Exchange;

Pursuant to Decision No. 22/QĐ-HDTV dated March 16, 2026, of the Member Council of the Vietnam Stock Exchange on the issuance of the Regulations on Listing and Trading of Listed Securities;

Pursuant to the application for amendment of listing registration submitted by BIDV Securities Joint Stock Company;

At the proposal of the Director of the Listing Management Department.

DECIDES:

Article 1. To approve the amendment of listing registration for BIDV Securities Joint Stock Company with the following details:

- Type of securities: common shares

- Par value: VND 10,000/share
- Number of listed shares before the change: **245.365.943 shares** (Two hundred forty-five million three hundred sixty-five thousand nine hundred forty-three shares)
