3. Supervisory activities of the BOD over the General Director

The Board of Directors performs the functions and duties prescribed in the Company Charter and Internal Regulations on corporate governance, develops and implements the 2026 BOD activity plan, and assigns specific tasks to BOD members in directing and supervising the executive activities of the General Director.

At the GMS on April 22, 2026, the BOD proposed amendments to: the Company Charter (9th amendment and supplement), Internal Regulations on corporate governance; Regulations on the operation of the Company's BOD; and presented the 2026-2030 Development Orientation of Cam Ranh Port Joint Stock Company, all of which were approved by the GMS.

Immediately after the General Meeting of Shareholders, the Board of Directors issued Resolution No. 253/2026/NQ-CCR.HĐQT to direct the Company's General Director to complete the assigned plan targets in Resolution No. 01/2026/NQ-CCR.ĐHĐCĐ.

In the first 6 months of 2026, the BOD performed the direction and supervision of the General Director's executive activities in the following areas:

- Directing and orienting the General Director through the issuance of Resolutions and Decisions related to business operations; investment, digital transformation; organization, personnel, labor, and salary work; cost control and waste prevention; standardization of the Internal Governance System and other important issues within the authority of the Board of Directors, in accordance with the current regulations and policies of the Company and the law.

- Regularly reviewing and evaluating the General Director in implementing the contents of the Resolutions and Decisions issued by the BOD regarding timelines and results of implementation solutions to ensure effective deployment. Monitoring compliance with the Law on Enterprises, the Company Charter, and current state regulations in all aspects of the General Director's executive activities.

- Directing and supervising the General Director in implementing investment projects on infrastructure construction, warehouse expansion, equipment procurement, etc., ensuring synchronization, efficiency, compliance, and suitability to market trends, technology, the Green Port development plan for the 2025-2030 period (Decision No. 190/2025/QĐ-CCR.HĐQT); the digital transformation plan for the 2025-2030 period (Decision No. 644/205/KH-CCR.HĐQT) and the development orientation of Cam Ranh Port for the 2026-2030 period and vision to 2035.

- Directing and strictly controlling effective cost management in production and business activities. Supervising financial work, risk management, labor and salary, etc.

- Strictly supervising the operating cost management of the General Director in the face of strong fluctuations in gasoline prices; optimizing exploitation productivity; directing the strengthening of customer debt risk control during the service provision process in the context of strong growth in Trade and Logistics revenue, ensuring revenue scale development goes hand in hand with corporate financial safety.

- Supervising the implementation of periodic financial reporting and information disclosure to ensure transparency, timeliness, and compliance with regulations.

The provision of information and reports to non-executive BOD members is carried out regularly and fully by sending documents via email and providing direct information at meetings about the Company's operational status, thereby promptly unifying opinions and issuing Decisions to direct and supervise the General Director.

The General Director carries out the process of seeking opinions for all matters under the decision-making authority of the Board of Directors and reports to the Board of Directors on the implementation of assigned duties and powers in accordance with regulations. The General Director assigns specific tasks and delegates strong authority to the Deputy General Director in business, exploitation, etc. Periodically organizes monthly and weekly briefing meetings with unit managers to evaluate work performance and implement work plans. The Chairman of the BOD and the BOD's assisting departments participate in monthly briefing meetings with the Board of Management to promptly grasp the Company's operational situation, thereby providing orientations and directing work aspects closely aligned with reality.

* BOD supervision results: The Board of Management implemented the Company's production and business activities in the first 6 months of 2026 in accordance with the goals, orientations, and directions in the GMS resolution, BOD resolutions, and in compliance with regulations, internal policies, the Company Charter, and legal provisions; effectively performing the role of risk control in corporate management.

4. Activities of committees under the Board of Directors

Based on the practical situation in business operations, the BOD established a General Board under the Company's Board of Directors according to Decision No. 163/2025/QĐ-CCR.HĐQT dated April 8, 2025, with the function of performing internal audit tasks and the tasks of the Person in charge of Corporate Governance as prescribed by law and the Company Charter.

- The Person in charge of Corporate Governance assisting the BOD has successfully fulfilled the functions and duties in accordance with the Law, the Charter, and the Internal Regulations on Corporate Governance.

- The Board of Directors issued the 2026 internal audit plan, and in the first 6 months, the General Board carried out 09 audit contents on the activities and compliance of units under the Board of Management in the following fields: exploitation; business; investment, IT; cost and debt management; labor and salary.

On April 22, 2026, the GMS dismissed Ms. Tran Thi Thanh Thuy from the Board of Supervisors and elected Mr. Tran Minh Duc as an additional member of the Board of Supervisors for the 2025-2030 term of Cam Ranh Port Joint Stock Company.

2. Supervisory activities of the SB over the BOD, Board of Management, and shareholders

In the first 6 months of 2026, the Board of Supervisors (SB) fully performed its functions and duties as prescribed in the Company Charter and the approved 2026 Supervision Plan, specifically:

- ***Supervision of financial and production/business activities:*** Appraising the 2025 separate and consolidated financial statements; supervising the implementation of setting aside and using funds (salary, reward, welfare funds) in 2025 and the results of financial and business activities for the Q1/2026 reporting period.

- ***Supervision of management and administration:*** Fully attending regular BOD meetings, promptly accessing BOD documents and resolutions, and executive documents of the General Director. Thereby, the SB assessed that the BOD and the Board of Management have performed their roles and duties well according to their authority; the issued resolutions and decisions strictly comply with the Charter, GMS Resolutions, and relevant legal regulations.

- ***Supervision of GMS organization:*** Comprehensively supervising the preparation and successful organization of the 2026 Annual General Meeting of Shareholders on April 22, 2026.

- ***Supervision of compliance in perfecting the regulatory system and Information Disclosure:***

+ The Board of Directors timely amended and issued foundational governance regulations (Charter, Internal Regulations on corporate governance, BOD Operation Regulations, Financial Management Regulations, Internal Normative System Governance Regulations) in accordance with their authority, creating a synchronous legal corridor and strict risk control.

+ The Board of Management proactively developed and re-issued the Labor Rules and 19 standard operating procedures (SOPs) in the fields of business, administration, exploitation, finance, and security to optimize corporate operational efficiency.

The Company has carried out full, public, and transparent information disclosure in strict compliance with regulations for public companies.

- ***Regarding shareholders:*** In the first 6 months of 2026, the SB did not receive any complaints, denunciations, or requests for clarification from shareholders or groups of shareholders related to the Company's governance and administration.

* **General assessment:** In the first 6 months of 2026, the Board of Supervisors maintained close, independent, and objective coordination with the BOD and the Board of Management. No overlap or obstacles were recorded during the performance of duties. The recommendations and notes of the SB were seriously accepted and promptly remedied by the Board of Management, contributing to improving risk management capacity, preserving capital, and optimizing the Company's production and business efficiency.

3. Coordination between the SB and the activities of the BOD, Board of Management, and other managers

- The activities of the BOD, Board of Supervisors, and Board of Management are operated synchronously in accordance with the Law on Enterprises, the Charter, and the Company's internal governance regulations. The operational relationship is maintained on the principle of close coordination, respecting the independence of the Board of Supervisors in accordance with prescribed functions and authority.

- The Board of Supervisors proactively discussed and reached a consensus with the BOD on the content and plan for periodic inspection and supervision; at the same time, it coordinated effectively with the Board of Management and managers of subordinate units throughout the process of performing duties to optimize internal control work.

- The BOD and Board of Management created maximum favorable conditions for the SB's activities by providing full and timely resolutions, decisions, reports, and documents related to all aspects of the Company's production and business activities. At the same time, the BOD seriously accepted the SB's recommendations, promptly directing and strictly supervising the Board of Management in implementing remedial measures.

- The close and consistent coordination between the BOD, Board of Supervisors, and Board of Management in the first 6 months of 2026 ensured that all corporate executive activities always strictly complied with legal regulations, improved risk management capacity, and maximized benefits for shareholders.

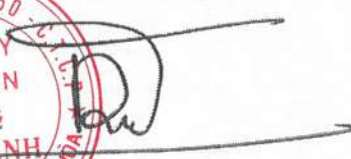
