II. PURPOSE OF THE WRITTEN CONSULTATION

The Chairman of the Board of Directors (the “Board”) of Hanoi Investment General Corporation organized the collection of shareholders' written opinions in order to approve the following matters:

1. Change of the Company's business lines/sectors.
2. Amendment and supplementation of the Company's Charter.
3. Policy on adjusting the deferred-payment debt limit of Thang Long Thermal Power Joint Stock Company.

III. GENERAL INFORMATION

1. Charter capital of the Company: VND 1,296,071,470,000.
2. Total number of shares of the Company: 129,607,147 shares, all being ordinary shares.
3. Total number of voting shares: 129,607,147 shares, corresponding to 129,607,147 voting ballots.

IV. RESULTS OF BALLOT VERIFICATION

1. Each shareholder received one written Consultation Ballot (“Opinion Ballot”) from Hanoi Investment General Corporation. Each share held by a shareholder corresponds to one voting ballot.
2. Number of Opinion Ballots submitted directly to the Company: 26 Opinion Ballots, representing 119,998,725 ordinary shares, corresponding to 119,998,725 votes, accounting for 92.59% of the total voting rights, of which:
 - Number of valid Opinion Ballots: 26 ballots, representing 119,998,725 shares.
 - Number of invalid Opinion Ballots: 0 ballots, representing 0 shares.

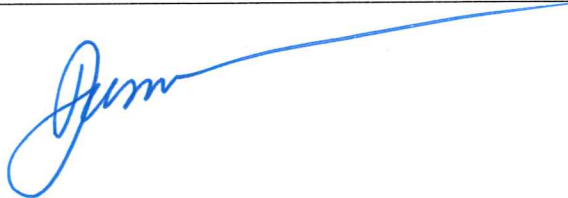
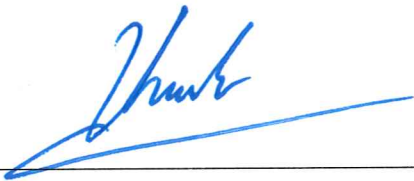
